The Federal Motor Carrier Safety Administration establishes specific requirements for driver rest periods, vehicle inspection protocols, and cargo securing procedures. Violations of these regulations can establish negligence per se, creating liability independent of traditional fault analysis.

The settlement process in commercial trucking cases often involves negotiations with multiple insurance carriers, as trucking companies typically maintain layered coverage structures with primary and excess policies. Additionally, separate coverage may exist for the tractor, trailer, and cargo, requiring coordination among various insurers.
